

Directions: For use as a stain removing solution:

 Always pre-test all cleaning solutions in an inconspicuous area for colorfastness.

 Carefully mix 2 powder oz. of CSR into 1 qt. of hot water into a trigger sprayer. Read side panel for cautions. Avoid inhaling powder or vapor.

3. Make certain CSR is thoroughly mixed.

Saturate spray stained area with mixed solution.
Allow 2-5 minutes of dwell time

5. If trace amount of stain remains after drying, repeat

application.

 After stain removal, vacuum or extract textile.
For faster drying, especially in humid environments, consider using an axial, centrifugal, or downdraft air mover


Browning prevention additive for upholstery cleaning:

 Mix founce of CSR with each mixed gallon of HydraMaster FabricMaster Fine Fabric Prespray.
