Utilizing reducing and polymer technology, **Red Break 1** alters the structure of difficult stains by removing them or making them invisible. **Red Break 1** is a one part system that requires no mixing and no waste of product.

Directions:

1. Always pre-test all cleaning solutions in an inconspicuous area for colorfastness prior to application.
2. Clean the stained area with normal cleaning processes prior to the application of this product. Take an extra dry vacuum pass to remove as much moisture as possible.
3. **Red Break 1** is a one part solution. Liberally apply solution straight to the stained area.
4. Allow 30 seconds to two minutes of dwell time. Many stains are removed simply by extracting the area with clear water at this point.
5. If residual discoloration remains, reapply straight solution liberally directly to the stain.
6. Accelerate activity with heat. If using a low pressure, high volume steam generator such as a wallpaper steamer, simply allow steam wand to sit on treated area. Check stain periodically every 30 seconds to 2 minutes. If using a steam iron, cover stained area with a wet white, colorfast cotton towel. Apply steam heat from iron set at the lowest steam temperature. Lift and move the iron every 20-30 seconds and check the area.
7. When the stain has completely disappeared, simply extract the area with clear water. If a slight yellow discoloration remains, simply allow the area to completely dry and the discoloration will usually go away.
8. Use caution when using a product of this type. Color loss or fiber damage caused by excessive heat can be avoided by being diligent in periodically checking the area.

Instrucciones:

1. Red Break 1 es una solución de una parte. Aplique la solución directamente a la zona manchada.
2. Espere 30 segundos a dos minutos de tiempo de permanencia. Muchas manchas se eliminan simplemente mediante la extracción de la zona con agua limpia en este punto.
3. Si queda decoloración residual, vuelva a aplicar la solución directamente a la mancha.
4. Acelere la actividad con calor. Si se utiliza un generador de vapor de baja presión y alto volumen, como un vaporizador para papel tapiz, simplemente coloque el tubo de vapor en el área tratada. Compruebe mancha periódicamente cada 30 segundos a 2 minutos. Si se utiliza una plancha de vapor, cubra el área manchada con una toalla blanca mojada que no se destiña. Aplique calor de vapor de la plancha en la temperatura más baja posible. Levantar y mover la plancha cada 20-30 segundos y revisar el área.
5. Cuando la mancha ha desaparecido por completo, sólo tiene que extraer el área con agua limpia. Si una ligera coloración amarilla sigue presente, simplemente permita que el área se seque por completo y la decoloración por lo general desaparece.
6. Tenga cuidado al usar un producto de este tipo. Pérdida de color o daño de las fibras causado por el calor excesivo puede evitarse por ser diligente en la comprobación periódica de la zona
